# BARK BARN KENNEL LIABILITY RELEASE AND MEDIA CONSENT FORM

This form represents a contract between Bark Barn Kennel (Kennel) and pet owner (Owner) whose signature is provided below. In presenting Owner's pet(s) for service at Kennel, Owner and Kennel agree to the following:

1. Kennel agrees to exercise due diligence, reasonable care and to keep kennel premises clean, properly secured and safe for pets in its care.
2. Owner recognized the inherent risks to pet(s) of illness or injury associated with the care of animals in a kennel environment. Such risks include but are not limited to problems resulting from rough play and kennel cough.
3. Owner is aware that pet(s) will co-mingle with pet(s) owned by others in a supervised environment unless Owner specifically requests their pet(s) not co-mingle.
4. Owner agrees to pay for all services provided during pet(s) stay at the rates effective on the date the pet(s) is checked into the Kennel.
5. Owner certifies that all information provided to the kennel is accurate and complete, that the pet(s) has not been exposed to Rabies or Distemper within a 30-day period prior to presentation for service and that all required pet vaccinations are up-to-date at the time of service.
6. Owner understands and agrees that Kennel staff relies on Owner's representation on the health of the pet(s) being presented for services and the truth about any aggressive or threatening behavior towards a person or another animal. Owner hereby indemnifies Kennel, its owners and representatives, with regard to any claims arising from any aggressive behavior of Owner's pet(s).
7. Kennel will not be liable for lost, stolen or damaged personal property left with pet(s) at Kennel.
8. Owner understands and agrees that Kennel and their staff, employees, representatives and volunteers will not be liable for any problems which develop, including but not limited to loss by fire, theft, run-away pet, death or injury. Owner hereby releases and discharges Kennel, its owners, employees, representatives and volunteers from any and all claims, damages, liability and/or causes of action of any kind arising from Owner's pet(s) attendance at Kennel except where any such loss is caused by negligent or intentional acts of any of the aforementioned parties.
9. Owner understands and hereby authorizes Kennel, at Kennel's discretion, to treat pet(s) for fleas and ticks while the pet(s) is receiving services at Kennel. Such treatment will be at Owner's expense.
10. Charges for services rendered by Kennel or Kennel's representatives shall be payable upon pickup of pet(s). Kennel shall have, and is hereby granted, a lien on the pet(s) for any and all unpaid charges due to Kennel for services provided.
11. Owner understands that pet(s) may become ill or injured while in the care of Kennel and that every effort will be made to notify Owner as soon as possible, should illness or injury occur, via the Owner's contact information. In the event Owner is not reached or unable to specify which measures Owner wishes to be taken, or in the event that Kennel, in its sole discretion, determines that emergency action is required, Kennel shall contract with a veterinarian or other professional to evaluate and provide necessary care to pet(s). Costs incurred for such services shall be at Owner's expense.
